VDA Takes Firm Action Against Illegal Construction in Varanasi

Sealing Action: Enforcement Crackdown on Illegal Construction in Varanasi

Following instructions from the Vice Chairman, the enforcement team of Varanasi Development Authority, Zone-1, executed sealing proceedings against illegal construction. Shivkumar, son of Shambhu Nath, constructed a building with B+G+3 floors, measuring approximately 40 × 50 square feet in Mauja Babatpur, Ward-Shivpur, District-Varanasi, without proper approvals. A show cause notice and a stop-construction notice were issued on May 20, 2024, under sections 27, 28(i), and 28(ii) of the Uttar Pradesh Town Planning and Development Act, 1973. Despite these notices, construction continued, leading to the sealing of the unauthorised structure on May 21, 2024. The site was handed over to Police Station Badagaon for continuous monitoring. Zonal Officer Singh Gaurav Jai Prakash and Assistant Engineer Ambrish Kumar Sharma were present during the action.




Vote; VDA's Pledge for General Elections Oath-Taking Ceremony to Encourage Voting Organized by VDA

VDA Enforces Regulations, Seals Illegal Construction Varanasi Development Authority Takes Action

Against Illegal Construction in Zone-4

In line with the Vice Chairman's instructions, the

enforcement team of Varanasi Development Authority, Zone-4, executed sealing proceedings against illegal construction. Kashi Chaurasia, son of late Salik Ram Chaurasia, had illegally constructed shops and performed shuttering work on a 26×33 feet area near Mauja Bachhav Indian Oil Petrol Pump in Ward-Nagwan without obtaining the required map approvals. Under sections 27, 28(i), and 28(ii) of the UP Town Planning and Development Act, 1973, notices were issued against this unauthorised construction.


